### MEMORANDUM

TO: Common Council

RE: Insurance Plan Veto

### Council Members -

After another restless night and extensive discussion with staff and Ald. Sloan, I have decided to veto the Council's Tuesday action on item 12.4, selecting P-17 as the employee health insurance plan. As always, this is not a step I take lightly, and I am reluctant to go against the majority's wishes, but I believe there are three factors which justify re-visiting this issue:

- 1) The impact on staff morale has already been quite dramatic, and I'm getting reports that the fallout of Tuesday's decision has been swift and intense. People are *very* upset. These are employees who have been loyal to the City for many years, and I think at the very least, we owe it to them to give them an opportunity to be heard and take their concerns seriously.
- 2) After conversations with a couple of alderpersons, it seems like the data presented during the discussion last night was difficult to understand, especially as several of us were crunching numbers on the fly. I would like to see our options presented in a format that makes it easier to compare "apples to apples," and for everyone to get this information well in advance of the meeting. My sense is that others would appreciate that, too. In addition, the lateness of the hour (especially after two thrilling insurance presentations) perhaps had dulled our collective senses, and I think we should approach this topic while at our sharpest.
- 3) Most critically, I was advised by Lori yesterday that some of the figures presented to Council on Tuesday night were incorrect. Part of this was a clerical mistake, and part was a consequence of bad information from the state. As a result of her re-calculations, the P-17 plan is approximately \$30,000 more expensive than we were led to believe at the time of the vote. This obviously changes how the different options stack up and could subsequently impact how alderpersons wish to vote. I will forward a copy of Lori's message for your reference.

Brenda has gotten us an extension on selecting a plan until October 5. Nonetheless, we are still under an extreme time crunch to get this decision made, so I am requesting a special Council meeting on **Tuesday**, **October 3 at 7:00 p.m.** 

I regret the short notice and the inconvenience to all of us, but I really think it is worth a second look at this issue in order to make sure we are getting it right. At Tuesday's meeting, we will continue the Committee of the Whole discussion prior to Council consideration of a veto override. Depending on the outcome of that vote, Council may then have an opportunity to select a different plan option.

In an effort to limit additional extra meetings, Casey has volunteered to present his economic development update at this time, as well.

Again, my regrets for any inconvenience that this causes, and I really appreciate your dedication to doing what is in the long-term best interest of our City, staff, and residents.

**Background:** At the September 26, 2023 Common Council meeting Council members elected to change the health insurance program offered to employees to the "Local High Deductible Plan" at the rate currently set by the Personnel policy of 90% City funded and 10% employee funded, with the City contributing the full deductible through a Health Reimbursement Arrangement (HRA). Since this meeting, staff has found errors in the calculations that were provided that made this option the lowest cost to the City. An Ordinance revising the City of Baraboo Code of Ordinances §7.08 Speed Limits.

THE COMMON COUNCIL OF THE CITY OF BARABOO, WISCONSIN, DO ORDAIN AS FOLLOWS:

- 1. The City of Baraboo Code of Ordinances § 7.08 is revised as follows:
- **7.08 SPEED LIMITS**. The Council hereby determines that the statutory speed limits on the following streets or portions thereof are unreasonable, unsafe and imprudent and modifies such speed limits as follows:
  - (2) SPEED LIMITS DECREASED. The speed limits are decreased, as hereinafter set forth, upon the following streets or portions thereof:
    - (a) 15 Miles Per Hour.
      - 1. On Zoo Lane between Park Street and Ridge Street.
      - 2. All alleys.
    - (b) 25 Miles Per Hour.
      - 1. On South Boulevard between State Hwy 136 and Commerce Parkway. (2058 06/26/2001)
      - 2. Manchester Street. (2091 08/27/02)
      - 3. Madison Avenue between Crawford and East Street. (2135 01/27/04)
      - 4. Man Mound Road between CTH T (Taft Avenue) and the easterly City Limits.
- 2. This Ordinance shall take effect upon passage and publication as provided by law.
